**ORDINANCE NO. 541, S-2014**

**ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 508, S-2012, THE  
 CREATION OF THE LOCAL AIDS COUNCIL FOR THE PREVENTION AND  
 CONTROL OF HIV/AIDS IN THE CITY OF MANDALUYONG IN  
 COMPLIANCE WITH REPUBLIC ACT 8504**

BE IT ENACTED by the Sangguniang Panlungsod of Mandaluyong in regular session duly assembled:

SECTION 1. TITLE. The composition of the Local HIV/AIDS Council of the City of Mandaluyong is hereby amended as follows:

Chairperson	City Mayor
Vice-Chairperson	Sanggunian Committee Chairman on Health/Social Concerns
Member	Health Officer
Member	Social Welfare Officer
Member	DILG Officer (PD/CD/CLGOO/MLGOO)
Member	DOH Representative
Member	Superintendent/Representative from DepEd
Member	One (1) Representative from an Organization of People Living with HIV (to be engaged/ if none organized)
Member	One (1) Representative from a Faith-Based Organization
Member	One (1) Representative from Accredited NGO/ PO representing or working with groups vulnerable or most risk to HIV
Member	One (1) Representative from an agency/institution as identified by the concerned LGU (business sector/ academe)
Secretariat	STI, HIV, and AIDS Local Focal Person

SECTION 2. FUNCTIONS. The Local AIDS Council (LAC) shall serve as the coordinating, planning, implementing, and monitoring body on HIV/AIDS prevention programs and policies in the City of Mandaluyong.


SECTION 3. IMPLEMENTING RULES AND REGULATIONS. The City Mayor shall promulgate the necessary Implementing Rules and Regulations for the efficient implementation of this Ordinance in compliance with the mandates of Republic Act 8504.

SECTION 4. BUDGETARY REQUIREMENTS. The amount of ONE MILLION FIVE HUNDRED THOUSAND PESOS (P1,500,000.00) is hereby appropriated for the implementation of this Ordinance as embodied in the 2013 Executive Budget. Succeeding proposed budget for the annual operation shall be allotted every year to be fixed by the Council to be submitted to the Budget Officer for subsequent approval by the Sangguniang Panlungsod.

SECTION 5. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
