ORDINANCE NO. 555, S-2014

**AN ORDINANCE REQUIRING ALL BUSINESS ESTABLISHMENTS AND
OCCUPATIONAL UNDERTAKINGS TO SECURE BUSINESS
PERMIT PRE-NUMBERED REGISTRATION PLATE**

WHEREAS, the City is experiencing a rapid growth not only in terms of population but in industrial and commercial activities, as well. The Local Government needs imperative moves to attune its action program to generate more revenues to support the basic services required by its constituent in the light of these socio-economic development;

WHEREAS, to support the action programs, there should be an effective system of registration and regulation of all business establishments and occupational undertakings via the issuance of Pre-Numbered Registration Plate to all business establishments and occupational undertakings before the start of their business operation;

WHEREAS, the prominent display of the pre-numbered business plates will greatly assist the City Government in its campaign to register all business establishments in Mandaluyong;

BE IT ORDAINED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled:


- SECTION 1. **COST/REGULATORY EXPENSES.** All business/commercial establishments are hereby required to secure a Business Permit/License Pre-numbered Registration Plate (BPLRP) from the Business Permit and License Department (BPLD) and to pay the corresponding amount of Two Hundred Twenty Pesos (P220.00) per plate representing the cost and regulatory expenses therefore.
- SECTION 2. **RENEWAL COST/REGULATORY EXPENSES.** The Business Permit/ License Registration Plate may be used for a period of three (3) years, replaceable thereafter, but shall be renewed yearly with a printed sticker bearing the current year of issuance visibly indicated and attached to the Business Permit/License Pre-numbered Registration Plate (BPLRP). The cost and regulatory expenses of which the amount of Sixty Six Pesos (P66.00) shall be chargeable to the entities/enterprises concerned.
- SECTION 3. **TIME OF PAYMENT.** All fees shall be paid to the City Treasurer on or before every 20th of January.
- SECTION 4. The Business Permit/License Pre-numbered Registration Plate (BPLRP) shall be permanently and conspicuously displayed within the establishment concerned that is visible to public view.
- SECTION 5. The City Mayor, through the Business Permit and License Department is hereby authorized to promulgate by Executive/Memorandum Order the Implementing Rules and Regulations (IRR) necessary for the proper implementation of this Ordinance.
- SECTION 6. Violation of any provision of this Ordinance shall be penalized a fine of Two Hundred Pesos (P200.00) but not exceeding One Thousand Pesos (P1,000.00) or imprisonment of one (1) month but not more than six (6) months or both at the discretion of the court.

SECTION 7. REPEALING CLAUSE. Ordinance No. 196, S-1996 and any Ordinance not consistent with the provisions of this Ordinance is hereby repealed.

SECTION 8. This Ordinance shall take effect immediately.
