RESOLUTION NO. 2372, S-2016

A RESOLUTION RECOMMENDING THAT HONORABLE CITY MAYOR CARMELITA A. ABALOS REPRESENT THE CITY OF MANDALUYONG IN ENTERING INTO A MEMORANDUM OF UNDERSTANDING WITH THE NATIONAL COMMISSION FOR CULTURE AND THE ARTS (NCAA), RELATIVE TO THE CITY'S CULTURAL MAPPING PROGRAM

WHEREAS, there is a joint effort and collaboration between the City of Mandaluyong, through its Cultural Affairs and Tourism Department with the National Commission for Culture and the Arts (NCAA), anent the implementation of the Cultural Mapping Program as mandated by Republic Act No. 7356, Republic Act No. 10066, Republic Act No. 7160 and other existing laws to conserve, promote and protect the nation's historical and cultural heritage;


WHEREAS, a Memorandum of Understanding between the City and the NCAA has been prepared, thru the said Department. The terms and conditions are contained in the Memorandum, including the roles and responsibilities of the City; and that the provisions therein are in accordance with the law, and that the City recognizes the mandate of the Constitution to conserve, promote and popularize the nation's historical and cultural heritage and resources;

WHEREAS, under Section 16, Republic Act 7160 (Local Government Code of 1991), the law encourages every Local Government Unit to ensure and support the preservation and enrichment of culture.

NOW, THEREFORE, BE IT RESOLVED, by the Sangguniang Panlungsod of Mandaluyong, in session assembled, as it is hereby RESOLVED, to recommend to the Honorable City Mayor CARMELITA A. ABALOS, to enter into a Memorandum of Understanding in behalf of the City of Mandaluyong, with the National Commission for Culture and the Arts (NCCA) relative to the City's Cultural Mapping Program.
