RESOLUTION NO. 2830, S-2019

RESOLUTION RATIFYING AND CONFIRMING THE
AMENDMENT IN THE 2019 ANNUAL INVESTMENT
PROGRAM OF THE CITY GOVERNMENT OF MANDALUYONG

BE IT ADOPTED by the Sangguniang Panlungsod of the City of Mandaluyong in session assembled:

WHEREAS, the City Government of Mandaluyong has already prepared and passed the Annual Investment Program (AIP) for the year 2019;

WHEREAS, the Annual Investment Program (AIP) is focused on the City Government's Practical Visions and Strategic Directions and Specific Objectives and Policy Decisions, and outlined the programs, projects and activities designed and geared towards the delivery of divergent and basic services to the community;

WHEREAS, part of the AIP are the different priority projects funded by the 20% Local Development Fund as approved by the Local Development Council (LDC) of Mandaluyong City;

WHEREAS, it has been the policy of the City Government to spend wisely every single centavo of the approved budget efficiently and properly for the benefit of the people of Mandaluyong. However, no matter how much the administration tries to spend the budget for the purpose, there are circumstances beyond its control that will render the budget allotted for a certain activity inadequate or the purpose of the project can no longer be realized;

WHEREAS, one of the priority projects in 2019 that has been funded by the 20% Local Development Fund is the construction of the multi-purpose halls located at San Rafael Street, Barangay Plainview (P34,000,000.00) and at Boni Avenue corner Sen. Neptali Gonzales Street, Barangay San Jose (P13,348,240.00), which can no longer be implemented and realized due to physical and legal constraints;

WHEREAS, a resolution passed by the Local Development Council exists in this regard;

WHEREAS, other priority projects of the City Government included in the 2019 AIP, but not included in the list to be funded by the Local Development Fund is the construction of a three (3) storey multi-purpose hall located at Block 39, Welfareville Compound, Barangay Addition Hills;

WHEREAS, an amendment to the existing Annual Investment Plan for 2019 is imperative to include the foregoing to the list of priority projects funded by the 20% Local Development Fund.

NOW, THEREFORE, and upon motion duly seconded, the Sangguniang Panlungsod ng Mandaluyong, RESOLVED, as it hereby RESOLVES, to ratify and confirm the amendment of the 2019 Annual Investment Program the City of Mandaluyong.
