ORDINANCE NO. 559, S-2014

**ORDINANCE REQUIRING THE ANNUAL REGISTRATION
AND IMMUNIZATION OF DOGS**

BE IT ENACTED by the Sangguniang Panlungsod in session assembled:

- SECTION 1. All owners of dogs in the City of Mandaluyong shall register the same with the City Health Office, thru the Animal Shelter Veterinarian within three (3) months after birth.
- SECTION 2. No dog shall be registered with the City Health Office unless the same had been immunized against rabies. Upon presentation of the pet for registration, the City Veterinarian shall determine if the pet being registered had already been immunized. Succeeding immunizations should be during the (1st) first quarter of the ensuing year.
- SECTION 3. For purposes of this Ordinance, vaccination of dogs may be done by City Veterinarian or any licensed veterinarian (Mandaluyong based).
- SECTION 4. If the dog had no previous record of vaccination, the City Veterinarian shall cause the vaccination after payment of the fees herein prescribed.
- SECTION 5. If the dog being presented for registration has already been immunized by a licensed veterinarian, the City Veterinarian shall require the presentation of a certificate showing the name of the veterinarian who conducted the immunization and the date the vaccination was done.
- SECTION 6. The immunization done on a dog shall be effective for a period of one (1) year only, counted from the date of vaccination annually thereafter on or before the anniversary date of the last immunization, unless otherwise required by the City Veterinarian.
- SECTION 7. For purposes of this Ordinance, the following fees are hereby assessed and paid to the City Treasurer.

In addition, the actual cost of the vaccine/medical expenses of the victim shall be paid by the owner with the City Treasurer.

- SECTION 8. The City Veterinarian shall issue and monitor appropriate tags showing that a certain dog had already been registered with his Office and immunized against rabies.

The identification tag to be issued under this Ordinance shall contain sufficient information, like name of owner and address, the date of registration and latest vaccination.

- SECTION 9. Any owner of dog who shall fail to register or immunize his pet as required under this Ordinance shall be punished with a fine of not less than Five Hundred Pesos (P500.00) but not more than One Thousand (P1,000.00) or imprisonment of not less than fifteen (15) days but not more than thirty (30) days or both at the discretion of the Court.
- SECTION 10. Barangay Officials shall cause the dissemination of this Ordinance and to require all owners of dogs to abide by its provisions.
- SECTION 11. REPEALING CLAUSE. Ordinance No. 108, S-1992 and any Ordinance not consistent with the provisions of this Ordinance is hereby repealed.
- SECTION 12. EFFECTIVITY. This Ordinance shall take effect immediately upon approval.
