ORDINANCE NO. 650. S-2017

**AN ORDINANCE PROHIBITING SPITTING AND URINATING  
 IN PUBLIC PLACES. PROVIDING PENALTY  
 FOR VIOLATORS THEREOF**

WHEREAS, Mandaluyong City is committed to provide a healthy atmosphere to the residents and passersby and to maintain a clean and sanitary environment;

WHEREAS, the act of spitting and urinating in public places are insulting, offensive and revolting to the public sensibilities and proprieties;

WHEREAS, the smell of urine and the sight of sputum in the environment is undoubtedly unhygienic and unsanitary.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled:

SECTION 1. PROHIBITION. It shall be unlawful and shall be a public nuisance for any person to spit or urinate in public places to which the public has access and includes any street, highway, road, alley, sidewalks, parks, plaza, parking lots, or other vacant public and private properties not owned or controlled by the offender, other such areas open and in full view of the public.

SECTION 2. ENFORCEMENT. All Barangay Chairmen, Kagawads, Barangay Tanods, street sweepers are hereby authorized to enforce and implement the prohibitions of this Ordinance.

SECTION 3. PENAL PROVISION.

FIRST OFFENSE	Five Hundred Pesos (P500.00)
SECOND OFFENSE	One Thousand Five Hundred Pesos (P1,500.00)
THIRD OFFENSE	Two Thousand Pesos (P2,000.00)

SECTION 4. Any provision of existing Ordinances contrary or inconsistent with this Ordinance are hereby repealed or modified accordingly.

SECTION 5. This Ordinance shall take effect after its publication.
