ORDINANCE NO. 666, S-2017

ORDINANCE DECLARING CERTAIN ROADS/STREETS IN
MANDALUYONG AS NO PARKING/TOW AWAY
ZONE THEREBY AMENDING APPENDIX II
OF ORDINANCE NO. 588, S-2014
OTHERWISE KNOWN AS THE OMNIBUS
TRAFFIC MANAGEMENT CODE OF MANDALUYONG CITY

WHEREAS, the Metropolitan Manila Development Authority (MMDA) has declared express routes, otherwise known as Mabuhay Lanes, to and from various parts of the Metropolitan Manila after a new traffic plan was implemented on Epifanio Delos Santos Avenue (EDSA);

WHEREAS, the said lanes were tailored as alternate routes for private vehicles to avoid heavy traffic in some major roads in Metro Manila, especially EDSA, during rush hours;

WHEREAS, due to the declaration of certain streets in Mandaluyong as Mabuhay Lanes by the MMDA, some provisions of City Ordinance No. 588, S-2014 (Traffic Management Code of the City of Mandaluyong) are now in conflict with the MMDA Resolution, more particularly in defining and implementing one side parking and/or tow away zones, thus, there is a need to amend Appendix II of Ordinance No. 588, S-2014.

NOW, THEREFORE, BE IT ORDAINED, by the Sangguniang Panlungsod ng Mandaluyong, in session duly assembled that:


SECTION 1. Appendix II of Ordinance No. 588, S-2014 (Traffic Management Code of the City of Mandaluyong) is hereby repealed, amended and modified by declaring the following roads/streets as no parking-tow away zones:

- a. 9 De Febrero
- b. Acacia Lane
- c. Barangka Drive
- d. Bumatay
- e. Calbayog Extension
- f. Coronado
- g. F. Blumentritt (Rev. G. Aglipay)
- h. F. Ortigas
- i. Kalentong
- j. Luna Mencias
- k. Martinez
- l. P. Cruz
- m. Pantaleon
- n. San Francisco (Open Canal)
- o. Shaw Boulevard

SECTION 2. EFFECTIVITY. This Ordinance shall take effect upon its approval and after its publication in a newspaper of general circulation in Metro Manila.
