ORDINANCE NO. 688, S-2017

ORDINANCE AMENDING SECTIONS 1, 2 AND 4, OF ORDINANCE NO. 541, S-2014, THE CREATION OF THE LOCAL AIDS COUNCIL FOR THE PREVENTION AND CONTROL OF HIV/AIDS IN THE CITY OF MANDALUYONG IN COMPLIANCE WITH REPUBLIC ACT 8504

BE IT ENACTED by the Sangguniang Panlungsod of Mandaluyong in special session duly assembled:

SECTION 1. TITLE. The composition of the Local HIV/AIDS Council of the City of Mandaluyong is hereby amended as follows:

c.	HEALTH OFFICER	Member
d.	SOCIAL WELFARE OFFICER	Member
e.	DILG OFFICER (PD/CD/CLGOO/MLGOO)	Member
f.	DOH REPRESENTATIVE	Member
g.	SUPERINTENDENT/REPRESENTATIVE FROM DepED	Member
h.	ONE (1) REPRESENTATIVE FROM AN ORGANIZATION OF PEOPLE LIVING WITH HIV (TO BE ENGAGED/IF NONE ORGANIZED)	Member
i.	ONE (1) REPRESENTATIVE FROM A FAITH-BASED ORGANIZATION	
j.	ONE (1) REPRESENTATIVE FROM ACCREDITED NGO/PO REPRESENTING OR WORKING WITH GROUPS VULNERABLE OR MOST RISK TO HIV	Member
k.	ONE (1) REPRESENTATIVE FROM AN AGENCY/ INSTITUTION AS IDENTIFIED BY THE CONCERNED LGU (BUSINESS SECTOR/ ACADEME)	Member
l.	REPRESENTATIVE OF HEALTH EDUCATION AND PROMOTION OFFICE OR HEPO	Member
m.	SOCIAL HYGIENE CLINIC	Secretariat

SECTION 2. FUNCTIONS. The LOCAL AIDS COUNCIL (LAC), which will set a regular quarterly meeting with all Members, shall serve as the coordinating, planning, implementing, and monitoring body on HIV/AIDS prevention programs and policies in the City of Mandaluyong.

SECTION 3. IMPLEMENTING RULES AND REGULATIONS. The City Mayor shall promulgate the necessary Implementing Rules and Regulations for the efficient implementation of this Ordinance in compliance with the mandates of Republic Act 8504.

SECTION 4. BUDGETARY REQUIREMENTS. The amount of TWO MILLION PESOS (P2,000,000.00) is hereby appropriated for the implementation of this Ordinance. Succeeding proposed budget for the annual operation shall be allotted every year to be fixed by the Council to be submitted to the Budget Officer for subsequent approval by the Sangguniang Panlungsod.


