RESOLUTION NO. 2449, S-2017

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO ENTER AND SIGN A MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT-NATIONAL CAPITAL REGION (DILG-NCR) AND LOCAL GOVERNMENT ACADEMY (LGA) OF THE DILG FOR THE IMPLEMENTATION OF THE "SUSTAINABLE DEVELOPMENT GOALS FAMILY-BASED ACTIONS FOR CHILDREN AND THEIR ENVIRONS IN THE SLUMS (SDG-FACES) PROJECT IN THE CITY OF MANDALUYONG"

WHEREAS, the Government of the Philippines is a signatory to the United Nations Sustainable Development Goals of 2030;

WHEREAS, Republic Act No. 7160 or the Local Government Code of 1991 lays the foundation to the Local Government Units (LGUs) such as the City of Mandaluyong to be effective partners in the attainment of National Goals;

WHEREAS, the DILG is responsible to strengthen the capability of LGUs towards effective and efficient local governance, and it has a supervisory power over them;

WHEREAS, the LGA of the DILG is implementing the project entitled "Sustainable Development Goals Family-based Actions for Children and their Environs in the Slums (SDG-FACES) Project", and it requires the support of the City of Mandaluyong to implement and develop the project deliverables as provided in the Terms of Reference (ToR);

WHEREAS, basically, there shall be a one-time release of the amount of Fifty Thousand Pesos (Php 50,000.00) by the LGA through the DILG Regional Office to the SDG-FACES Project Sites for completion of the outputs under Article 1 of the Memorandum of Agreement (MOA);

WHEREAS, on May 5, 2017, the Office of the Mayor received a letter from Office of the Regional Director, DILG-NCR, informing the success of the First Business Meeting held on April 27-28, 2017 attended by the representatives of the City Government, and attached thereto is a copy of a MOA relative to the implementation of the SDG-FACES Project for review and approval;

WHEREAS, the SDG-FACES Project shall commence right after the First Business Meeting and the signing of the MOA, and all the activities and SDG-FACES Project deliverables shall end on December 31, 2017;

WHEREAS, relative thereto, the City Legal Department reviewed the MOA that defines the complementary undertakings of the parties, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, to authorize the Honorable Mayor CARMELITA A. ABALOS to enter into and sign a Memorandum of Agreement with the Department of the Interior and Local Government-National Capital Region (DILG-NCR) and Local Government Academy of the DILG (LGA-DILG) for the implementation of Sustainable Development Goals Family-based Actions for Children and their Environs in the Slums (SDG-FACES) Project in the City of Mandaluyong.






