RESOLUTION AUTHORIZING THE MEDICAL DIRECTOR OF THE MANDALUYONG CITY MEDICAL CENTER (MCMC), DR. ZALDY R. CARPESO. TO ENTER AND SIGN A CONTRACT OF LEASE WITH FARMACIA NI DOK INVOLVING AN 18.56-SQUARE METER PORTION OF THE MANDALUYONG CITY BIRTHING PLACE TO BE USED AS PHARMACY

WHEREAS, the Mandaluyong City Medical Center (MCMC) is a tertiary hospital owned and operated by the City Government of Mandaluyong, and under its care and management is the Mandaluyong City Birthing Place located at Martinez Street, Barangay Addition Hills, Mandaluyong City;

WHEREAS, in line with its mission to provide best health care services possible primarily for the residents, the City of Mandaluyong has continuously been improving and finding ways to better serve and deliver basic health services, including providing them affordable medicines and supplies within their reach;

WHEREAS, for this purpose, the City of Mandaluyong has been partnering with private entities in the medical field to aid them in delivering and providing these basic health services and supplies;

WHEREAS, "Farmacia Ni Dok", through its franchisee, MS. DONNA JEAN L. PALMA, shares a common mission and vision with the City of Mandaluyong as regards the delivery of basic health services and supplies, desires to lease for a consideration a portion of the birthing place and use the same as a pharmacy;

WHEREAS, a Contract of Lease has been crafted for the purpose, and the City Legal Department has reviewed the same and, after suggestion of some changes, found to be in order.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Medical Director of the Mandaluyong City Medical Center, DR. ZALDY R. CARPESO, to enter and sign the Contract of Lease, including the subsequent renewals thereof, with Farmacia Ni Dok involving a portion of Mandaluyong City Birthing Place consisting of 18.56 square meters to be used as pharmacy.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Honorable Mayor CARMELITA A. ABALOS at the Office of the Mayor, Mandaluyong City Medical Center (MCMC), Treasury Department and Accounting Department.
