A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO SIGN THE MEMORANDUM OF AGREEMENT AMONG THE DEPARTMENT OF THE INTERIOR AND LOCAL GOVERNMENT (DILG) MANDALUYONG FIELD OFFICE, CITY OF MANDALUYONG AND DEVELOPMENT ACADEMY OF THE PHILIPPINES IN RELATION TO THE CONDUCT OF SK MANDATORY TRAINING FOR THE DULY ELECTED SK OFFICIALS FROM ALL BARANGAYS OF MANDALUYONG CITY

WHEREAS, the City of Mandaluyong believes in the importance of the Mandaleño youth in nation-building and development of young leaders who will lead this City and nation in the future is imperative;

WHEREAS, Republic Act No. 10742 or the Sanggunian Kabataan (SK) Reform Act of 2015 and its Implementing Rules and Regulations mandate that any SK official and member of the LYDC must undergo the mandatory training program before he or she assumes office;

WHEREAS, the DILG, through the Local Government Academy, was tasked to spearhead the conduct of the SK Mandatory Training, and seeks to partner with LGUs such as Mandaluyong City and private entities for better facilitation of the program;

WHEREAS, to realize the benefits of the SK Mandatory Training, a Memorandum of Agreement was formulated among the DILG-Mandaluyong Field Office, City of Mandaluyong and Development Academy of the Philippines, which has been reviewed by the City Legal Department, and found to be reasonably and properly crafted.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the Honorable Mayor CARMELITA A. ABALOS to sign the Memorandum of Agreement among the Department of the Interior and Local Government (DILG) Mandaluyong Field Office, City of Mandaluyong and Development Academy of the Philippines in relation to the conduct of SK Mandatory Training for the duly elected SK officials from all barangays of Mandaluyong City.

RESOLVED FURTHER, that copies of this Resolution be furnished to the Honorable Mayor CARMELITA A. ABALOS at the Office of the Mayor, Local Youth Development Office, Department of the Interior and Local Government (DILG) Mandaluyong Field Office and Development Academy of the Philippines for their immediate information.
