RESOLUTION NO. 2595, S-2018

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE UNIVERSITY OF THE PHILIPPINES-PHILIPPINE GENERAL HOSPITAL (UP-PGH) ON THE DISPOSITION OF WHEELCHAIRS AND OTHER MOBILITY AIDS DONATED BY THE LATTER DAY SAINTS CHARITIES-PHILIPPINES, INC. (LDSC)

WHEREAS, the City of Mandaluyong is committed in promoting the realization of the rights of disabled persons to participate fully in the social life and the development of the societies in which they live and the enjoyment of the opportunities available to other citizens;

WHEREAS, guided by the *Magna Carta for Disabled Persons*, the City of Mandaluyong recognizes that that disabled persons are part of Philippine society, and it shall give full support to the improvement of their total well-being and integration into the mainstream of society. Disabled persons have the same rights as other people to take their proper place in society. They should be able to live freely and as independently as possible. Disabled persons' rights must never be perceived as welfare services by the Government;

WHEREAS, the City of Mandaluyong also recognizes the role of the private sector in promoting the welfare of persons with disability (PWDs) and shall encourage partnership in programs that address their needs and concerns;

WHEREAS, toward this end, the City of Mandaluyong agrees, together with the UP-PGH and LDSC, to cooperate with the humanitarian project to provide wheelchairs and other mobility aids to improve the mobility of PWDs in the City;

WHEREAS, a Memorandum of Agreement (MOA) was drafted for the parties involved to spell out the terms and conditions for the disposition of wheelchairs and other mobility aids donated by the LATTER DAY SAINTS CHARITIES-PHILIPPINES, INC. (LDSC);

WHEREAS, relative thereto, the City Legal Department reviewed the draft MOA, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, to authorize the Honorable Mayor CARMELITA A. ABALOS to sign the Memorandum of Agreement with the UNIVERSITY OF THE PHILIPPINES-PHILIPPINE GENERAL HOSPITAL (UP-PGH) on the disposition of wheelchairs and other mobility aids donated by the LATTER DAY SAINTS CHARITIES-PHILIPPINES, INC. (LDSC).

RESOLVED FURTHER, that copies of this Resolution be furnished to the Honorable Mayor CARMELITA A. ABALOS at the Office of the Mayor, Persons with Disabilities Affairs Division, Treasury Department, and Accounting Department for their immediate information.
