RESOLUTION NO. 2602, S-2018

A RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE MANDALUYONG CITY POLICE STATION AND THE NATIONAL POLICE COMMISSION FOR THE DEVELOPMENT OF PROGRAMS EFFECTIVELY STRENGTHENING THE PEACE AND ORDER, THE PUBLIC SAFETY AND JUSTICE DELIVERY MECHANISMS IN THE CITY OF MANDALUYONG

WHEREAS, every local government unit shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare, as per the Local Government Code;

WHEREAS, the City of Mandaluyong recognizes its role in ensuring the safety and protection of its constituents through programs and policies directed and related to the addressing of such aim;

WHEREAS, the promotion and maintenance of the peace of order in the City of Mandaluyong, as well as issues concerning the criminality and internal security of the City is duly vested with the Mandaluyong City Police Station, which exercises supervision and control over police units within the City jurisdiction;

WHEREAS, to recognize the efforts of the National Police Commission (NAPOLCOM), the Mandaluyong City Police and the City Government of Mandaluyong towards the development of peace and order and public safety mechanisms, as well as the improved access to effective justice mechanisms, the aforementioned bodies have committed themselves to advance these aims;

WHEREAS, toward this end, the Mandaluyong City Police Station, in cooperation with the NAPOLCOM, will commence its 23rd Police Community Relation Month celebration which concretizes the aforementioned agreement of the parties and create a strengthened partnership between the police and the community;

WHEREAS, relative thereto, the City Legal Department reviewed the draft Memorandum of Agreement that will govern the parties' complementary duties and responsibilities, and the same has been found to be reasonably and properly crafted and in accordance with law;

WHEREAS, there is a need to enact a Resolution authorizing the City Mayor, CARMELITA A. ABALOS, to enter into and sign the Memorandum of Agreement for and in behalf of the City Government with NAPOLCOM and the Mandaluyong City Police Station.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize Honorable Mayor CARMELITA A. ABALOS to enter into and sign the Memorandum of Agreement for and in behalf of the City Government with National Police Commission and the Mandaluyong City Police Station for the development of programs effectively strengthening the peace and order, the public safety and justice delivery mechanisms in the City of Mandaluyong.

FURTHER RESOLVED, as it hereby RESOLVES, that copies of this Resolution be furnished to the Office of the City Mayor, National Police Commission and the Mandaluyong City Police Station.
