A RESOLUTION GRANTING AUTHORITY TO THE HONORABLE CITY
MAYOR, CARMELITA A. ABALOS, TO ENTER INTO AND SIGN
THE **MEMORANDUM OF UNDERSTANDING BETWEEN**
FINE NUTRITION TRADING INTERNATIONAL
AND THE LOCAL GOVERNMENT OF MANDALUYONG

WHEREAS, Fine Nutrition International Trading (Fine) is one of the most awarded distributors of health and beauty products for Watsons Pharmacies and proud local partner of EarAccess Inc., duly organized and existing under Philippine laws with office address at S & F Condo 137B, Unit 304 Panay Avenue, Barangay South Triangle, Quezon City;

WHEREAS, Fine, in close partnership with EarAccess Inc., believes in making hearing care and hearing aids for all people everywhere. It also believes that living an exceptional life is a right that should be afforded to every person, including those with disabilities;

WHEREAS, Fine is working closely with EarAccess Inc. to use innovative technologies and capacity building/training programs to provide free hearing screenings to Filipinos, prioritizing early intervention and the identification of children with hearing loss by screening in schools and day care centers;

WHEREAS, the local government of Mandaluyong believes in the importance of early intervention for children with disabilities, and has agreed to collaborate with Fine in the latter's Access Project to conduct large scale hearing screenings of young children, particularly children under 5 years of age;

WHEREAS, a Memorandum of Understanding (MOU) between Fine and the local government of Mandaluyong, through its Persons with Disabilities Affairs Division, is necessary to set forth their complementary duties and responsibilities in this timely endeavor and a draft of the same was already reviewed by the City Legal Department;

WHEREAS, on the proposed MOU, Fine will, in connection with its Access Project, partner with the local government of Mandaluyong in providing free hearing screenings to children in daycare centers and elementary schools in the City of Mandaluyong, and refer the children identified to its clinic in order to provide follow-up and quality longer-term care. The MOU appears to be in accordance with law and is reasonably and properly crafted;

WHEREAS, there is a need to authorize the City Mayor, Honorable CARMELITA A. ABALOS, via a Resolution to enter into and sign the MOU between Fine and the local government of Mandaluyong.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to authorize the City Mayor, Honorable CARMELITA A. ABALOS, to enter into and sign the Memorandum of Understanding (MOU) between Fine Nutrition Trading International and the Local Government of Mandaluyong.


This Resolution shall take effect immediately upon its approval.
