A RESOLUTION ADOPTING METRO MANILA COUNCIL (MMC) RESOLUTION DATED MARCH 14, 2020 "ADOPTING A UNIFIED COMMUNITY QUARANTINE GUIDELINE WITHIN THE NATIONAL CAPITAL REGION TO PREVENT THE SPREAD OF THE NOVEL CORONA VIRUS (COVID-19)"

WHEREAS, there is an emergence of a novel corona virus that have been acknowledged by the global community to cause public health emergencies of international concern;

WHEREAS, the novel coronavirus (COVID-19) is a new strain of coronavirus that has not been previously identified in humans. The COVID-19 has caused severe pneumonia in several cases in China and has been exported to a range of countries and cities;

WHEREAS, globalization, which is characterized as rapid free movement of goods, services and people across the world, has contributed to the phenomenal spread of the COVID-19, and it now threatens the lives and safety of the Filipinos both here and abroad;

WHEREAS, the World Health Organization (WHO) has already made the assessment that COVID-19 can be characterized as a pandemic;

WHEREAS, on March 8, 2020, President Rodrigo Roa Duterte issued Proclamation No. 922 declaring a Public Health Emergency throughout the Philippines due to COVID-19;

WHEREAS, on March 12, 2020, the Inter-Agency Task Force for the Management of Emerging Infectious Diseases (IATF) issued Resolution No. 11, Series of 2020, and President Duterte approved the imposition of Stringent Social Distancing Measures in the National Capital Region (NCR) for thirty (30) days from March 15 to April 14;

WHEREAS, Resolution No. 11 has practically placed the entire NCR under community quarantine;

WHEREAS, there is a need for a uniform guideline to be followed by the local government units in the NCR in order to have a more cohesive response for the prevention of the spread of the disease.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED, as it hereby RESOLVES, to adopt the Metro Manila Council (MMC) Resolution dated March 14, 2020 "Adopting A Unified Community Quarantine Guideline Within the National Capital Region to Prevent the Spread of the Novel Corona Virus (COVID-19)".
