RESOLUTION NO. 2882, S-2020

A RESOLUTION ADOPTING MEMORANDUM CIRCULAR NO. 77 "DIRECTING ALL GOVERNMENT AGENCIES, OFFICES AND INSTRUMENTALITIES AS WELL AS LOCAL GOVERNMENT UNITS, TO IMPLEMENT AND ENSURE COMPLIANCE WITH THE ISSUANCES OF THE DEPARTMENT OF HEALTH AND DEPARTMENT OF AGRICULTURE ON THE PRICES OF ESSENTIAL EMERGENCY MEDICINES AND SUPPLIES, AND SELECTED AGRICULTURE AND FISHERY COMMODITIES"

WHEREAS, the novel Coronavirus, which caused the Corona Virus Infectious Disease - 19 (COVID-19), has already infected more than a hundred Filipinos;

WHEREAS, the World Health Organization (WHO) has declared COVID-19 a pandemic;

WHEREAS, the entire country was recently placed by President Rodrigo Roa Duterte under State of Calamity due to the COVID-19 outbreak;

WHEREAS, as the number of confirmed cases of COVID-19 infections rises everyday and in order to arrest rapid spreading of the virus, the President, on March 16, 2020, imposed the Enhanced Community Quarantine and the Stringent Social Distancing Measures over the entire Luzon, including the NCR, effective March 17, 2020 until April 12, 2020. Strict home quarantine is implemented in all households, and provision for food and essential health services is regulated;

WHEREAS, amidst the crisis, there is a need to protect our consumers, especially the Mandaleños, against hoarding, profiteering and cartels with respect to the supply, distribution, marketing and pricing of goods during the State of Calamity;

WHEREAS, the DOH issued Memorandum Nos. 2020 - 0058, 0058A and 0058B (s.2020), which mandate a price freeze on emergency medicines and medical supplies. The DA, likewise, issued Administrative Circular No. 1 (s. 2020), which imposes suggested retail price (SRP) for basic agricultural and fishery commodities in Metro Manila.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVES, as it hereby RESOLVED to adopt Memorandum Circular No. 77 "Directing All Government Agencies, Offices and Instrumentalities as well as Local Government Units, to Implement and Ensure Compliance with the Issuances of the Department of Health and Department of Agriculture on the Price of Essential Emergency Medicines and Supplies, and Selected Agriculture and Fishery Commodities", attached as Annex "A" and made an integral part hereof.
