

RESOLUTION AUTHORIZING THE HONORABLE MAYOR CARMELITA A. ABALOS TO SIGN THE MEMORANDUM OF AGREEMENT WITH THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)-FIELD OFFICE REGARDING THE SUPPLEMENTARY FEEDING PROGRAM FOR DAY CARE AND SNP CHILDREN IN MANDALUYONG CITY WITH ATTACHED MEMORANDUM OF UNDERSTANDING

WHEREAS, health welfare is one of the fundamental responsibilities of Local Government Units toward their constituents as embodied in the Local Government Code;

WHEREAS, it is a declared policy of the State to afford the children utmost protection, best care and proper nutrition at the family and community levels;

WHEREAS, the State, in its endeavor to address malnutrition among children, enacted Republic Act No. 11037 otherwise known as the "Masustansiyang Pagkain para sa Batang Pilipino Act of 2018". The law mandates the institutionalization of a comprehensive National Feeding Program for undernourished children in Public Day Care, Kindergarten and Elementary Schools noting the confirmed link between food and nutrition and the capacity of children to develop and learn;

WHEREAS, the DSWD, in its mandate to provide social welfare and development programs, particularly through technical assistance and resource augmentation, has been providing community-based nutrition programs and services such as Food for School and Healthy Start Feeding Program in child development centers at the Local Government Units (LGUs), and partnership with Non-Government Organization (NGOs) is employed to promote community participation;

WHEREAS, towards this end, DSWD sought for collaborative engagement with the City of Mandaluyong for the 120 Days Supplementary Feeding Program (SFP) for Day Care and SNP Children, School Year 2019-2020;

WHEREAS, relative thereto, the City Legal Department reviewed the draft MOA that will govern the parties' complementary duties and responsibilities, and the same has been found to be reasonably and properly crafted and in accordance with law.

NOW, THEREFORE, on motion duly seconded, the Sangguniang Panlungsod of Mandaluyong, in session assembled, RESOLVED to authorize the Honorable Mayor CARMELITA A. ABALOS to sign the Memorandum of Agreement with the DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT (DSWD)-FIELD OFFICE regarding implementation of the Supplementary Feeding Program for Day Care and SNP Children in Mandaluyong City.

RESOLVED FURTHER, that copy of the Resolution be furnished to the Honorable Mayor Carmelita A. Abalos at the Office of the Mayor, Day Care Service Program Division, and Accounting Department for their immediate information.
